### **1. Preparation of the Draft Meath County Development Plan 2019-2025**

Following consideration of the Chief Executive's Report to receive directions from the members of the Planning Authority regarding the preparation of the draft development plan in accordance with Section 11 (4) (d) of the Planning & Development Acts 2000-2016.

*'Any such direction shall be strategic in nature, consistent with the draft core strategy, and shall take account of the statutory obligations of any local authority in the area and any relevant policies or objectives for the time being of the Government or of any Minister of the Government, and the Chief Executive shall comply with any such directions'*

In issuing directions under paragraph (d), the members shall be restricted to considering the proper planning and sustainable development of the area to which the development relates.

The Members received a comprehensive presentation from Wendy Bagnall, Senior Executive Planner, on the Chief Executive Report and complimented Wendy and the Planning Staff on

the contents of same. They also welcomed the extent of public participation during the public consultation period.

There was a short suspension of the meeting at 11.55am due to a controversy over speaking time. The meeting resumed at 12.10pm.

The Members gave direction on the preparation of the draft Development Plan as follows;

### **Vision and Core Strategy**

- Improve the quality of life for our citizens
- Sustainable 'Live Work' Communities
- Sustainable Rural Communities
- Need to prioritise the building of houses

### **Economic Development and Tourism**

- Need to build on the policies of the Economic Strategy which must be the driving force of the County Development Plan
- Economic value to the County of the proximity of Dublin airport
- Need to promote Meath more in terms of being an integral part of 'Ireland's Ancient East'
- Promote joined-up thinking with regards to Tourism, Heritage and Biodiversity, similar to how the LECs are run
- Development of greenways

### **Housing and Settlement Strategy**

- Lands that are to be zoned should be serviced and ready to be built on
- Community facilities to be provided in tandem with the delivery of housing
- Issue of hoarding of lands should be addressed

### **Social Strategy**

- Need to provide lands for community and recreational facilities
- Proposed using school campuses to provide youth and recreational facilities in the community
- Promotion of further well planned school campus development

- Promotion of the development of a Regional Hospital in Navan

### **Heritage, Cultural and Natural Assets**

- Need to protect our coast line from coastal erosion
- Protection of our World Heritage Site
- Collaboration with the OPW regarding the management of heritage sites

### **Infrastructure & Movement**

- Promotion of sustainable modes of transport as an alternative to car based solutions
- Take advantage of Enfield's transport links particularly its rail connectivity to the national gateway
- Improvement of transport links to airport
- Requirement for the delivery of the rail line to Navan
- The need for the planned western rail station in Dunshaughlin to move to the east to serve Dunshaughlin and Ratoath
- Promotion of green infrastructure

### **Environmental Services**

- Provision of recycling facilities
- Provision of solar panels on all new commercial developments
- Restoration of derelict buildings in our towns and villages

### **Rural Development**

- Need to improve on broadband services
- Renewal of rural settlements so as to support rural schools
- Acknowledged the need for one-off housing in certain circumstances but also encouraged the conservation and revitalisation of our villages

### **Miscellaneous**

- The Members acknowledged the difficulty the Planning staff had in preparing the draft Development Plan in the absence of the National Planning Framework and the final census statistics

- Members complimented the focus the Chief Executive Report had on community
