

**NOTICE OF PREPARATION OF THE  
DRAFT MEATH COUNTY DEVELOPMENT PLAN 2020-2026**

Notice is hereby given pursuant to Section 12 (1) (b) of the Planning and Development Acts, 2000-2019 that Meath County Council, being the Planning Authority for County Meath, has prepared, in accordance with the provisions of the above Act, a Draft Meath County Development Plan for the County of Meath.

The Draft Plan is accompanied by an Environmental Report, prepared in accordance with the Planning and Development (Strategic Environmental Assessment) Regulations 2004 – 2011 and an Appropriate Assessment, pursuant to Article 6 of the Habitats Directive 92/43/EEC.

The Draft Plan will be on public display **from Wednesday 18<sup>th</sup> December to Friday 6<sup>th</sup> March, 2020**, inclusive, and is available for inspection at the following locations

Observations or submissions must include the full name and address of the person(s) making the submission and where relevant, the body or organisation represented. Please note that observations or submissions will be made public on the website and at the offices of the Planning Department.

Please note submissions that are emailed **cannot** be considered and will be returned.

Observations or submissions must be received by **4.00pm on Friday 6<sup>th</sup> March, 2020**.

All observations or submissions received during the above time period will be taken into consideration before the making of the Meath County Development Plan 2020-2026.
